### **RELEASE, WAIVER, AND HOLD** **HARMLESS AGREEMENT**

I, the undersigned owner of the vehicle identified on the attached Pool Member and Vehicle Application Form, (hereinafter “Renter”) understand and agree that the Canterbury Woods Swim Club (CWSC) does not take ownership, custody, control or responsibility for / of any personal property (including, but not limited to, the vehicle, any associated personal property in or on the vehicle) while it is in the CWSC parking lot. Renter agrees and understands that presence and/or parking of the property does not create a bailment or duty of care under any law or regulation that might otherwise apply. Renter agrees to assume all risk of loss, including from theft, vandalism, fire, flood, or other risks of storage of personal property. Renter agrees that Renter is required to maintain adequate insurance on the vehicle and all contents to cover any potential loss or damage while my property and vehicle is in the CWSC parking lot. On behalf of myself and my heirs, spouses, executors, administrators, and assigns, Renter agrees to expressly forever waive, release, and discharge any and all claims for loss, damage, costs, charges, demands, and liabilities of whatever nature resulting out of the use of CWSC parking lot, whether known or unknown, against the CWSC and its present, former, or future successors and assigns, and all of its present, former, and future members, officers, directors, managing agents, employees, agents, trustees, and partners, in their individual and representative capacities. Renter also agrees to indemnify and hold harmless CWSC from all costs, claims, and liabilities of any kind resulting from my use of the CWSC parking lot. This release, waiver, and hold harmless agreement serves as an inducement to CWSC to allow me to use the CWSC parking lot.

## CWSC 2024-25 Off-Season RV Parking Program RV Parking Policies

Initial each line, sign at the bottom, and return with your Application and Release, Waiver, and Hold Harmless Agreement.

1. \_\_\_\_\_ This CWSC program is only available to CWSC members who are and remain in good standing.
2. \_\_\_\_\_ This off-season program runs from September 2024 through April 2025. I will remove my vehicle from the CWSC lot no later than April 30, 2025.
3. \_\_\_\_\_ Parking fee is \$65 per month. *Fee will not be pro-rated.* A discounted rate of \$400 for the eight-month program is offered.
4. \_\_\_\_\_ Payment must be made via check or through payment link on CWSC website. Payment is due the 1<sup>st</sup> of every month.
5. \_\_\_\_\_ Failure to pay timely may result in removal from the program and, if the vehicle is not removed, CWSC may have the vehicle towed at owner's expense.
6. \_\_\_\_\_ Title/registration and proof of insurance copies must be provided with the Application. Updated copies must be provided, and title/registration must remain current while in the CWSC lot.
7. \_\_\_\_\_ Vehicle must have current license plate. License plate registration must remain current on vehicle while parked in the CWSC lot.
8. \_\_\_\_\_ Assigned parking area must be kept clean. Storage of any items outside the vehicle (e.g., gas cans, tires, etc.) is strictly prohibited.
9. \_\_\_\_\_ Parking of commercial vehicles is strictly prohibited.
10. \_\_\_\_\_ Vehicle wheels must be chocked.
11. \_\_\_\_\_ Covers, if any, must remain in good order and secured to the vehicle. Torn/Shredded/unsightly covers must be removed.
12. \_\_\_\_\_ No major maintenance will be performed on vehicle while in the CWSC parking lot. Checking tire pressure, fluid levels, etc. may be done while on the premises, but the vehicle must be removed before adding oil, etc. "Major Maintenance" is defined as anything other than checking tire pressure, checking fluid, or general cleaning of the vehicle.
13. \_\_\_\_\_ Access to remove the vehicle will be accommodated by a gate key loaned to renter for the duration of their contract, or by any Board member.
14. \_\_\_\_\_ Only the vehicle identified in the Application and approved for parking can be parked in the CWSC parking lot.
15. \_\_\_\_\_ CWSC retains sole discretion to discontinue any CWSC parking program agreement at any time if it determines any CWSC requirements or policies are not being adhered to by the parking applicant.
